## COVID-19 Pandemic Emergency & Urgent Denturist Treatment Consent Form

Alberta Health Services require self-isolation for 14 days from the date a person has returned to Canada. \_\_\_\_\_ (Initial).

I understand that Alberta Health Services has asked individuals to maintain physical distancing of at least 2 metres (6 feet) and it is not possible to maintain the distance and receive denturist treatment. \_\_\_\_\_ (Initial).

I verify that I have not been identified as a contact of someone who has tested positive for novel coronavirus or been asked to self-isolate by Alberta Health, the Communicable Disease Control or any other governmental health agency . \_\_\_\_\_ (Initial).
